# 1. WAITING A CALL FROM OUR INVESTOR

Include 1-2 photos of the front yard, 1-2 photos of the backyard, and 6-7 photos of the interior of the house (1-2 photos per room).

Photograph all rooms to capture the overall condition. If there are any flaws, don't worry, you don't need to make any repairs.

## 2. COMMUNICATION WITH THE INVESTOR
